CITY OF MEADVILLE, CRAWFORD COUNTY, PENNSYLVANIA STORMWATER PROGRAM AND USER FEE APPEALS MANUAL

1. Introduction

The City of Meadville has established policies and procedures with regard to the appeal of the stormwater fee. The primary goals of the City's appeals program is to establish a process to address inaccuracies and challenges to the stormwater fee calculation.

The process provides owners the ability to appeal their stormwater fee(s) in order to address errors in the billing as well as to address special conditions or circumstances where the stormwater runoff from a parcel does not place the same demand on the City stormwater system or related services.

2. General Appeal Policies

2.1. Billing Error Appeal

Errors in billing include, but are not limited to the following:

- Incorrect parcel information;
- Incorrect parcel classification as Single Family Detached (SFD) or Non-Single Family Detached (NSFD);
- Inaccurate impervious area information/Equivalent Residential Units (ERUs); and
- Human error(s).

2.2. Special Conditions Appeals

Special conditions appeals address circumstances where the owner can demonstrate that the stormwater runoff from their parcel is not placing the same demand on the City system or services provided under the stormwater program as other impervious area.

2.3. Eligibility

Any owner may appeal their stormwater fees with regard to errors or inaccuracies within the billing system.

Any owner may appeal their stormwater fee as a Special Conditions Appeal (SCA), provided the owner can demonstrate that:

- Their parcel(s)'s stormwater runoff impact on the stormwater system or services is significantly less than suggested by its amount of impervious area; and
- Their parcel or a portion thereof drains completely outside of the City.

All applicants must be current with their stormwater fees in order to be eligible for a SCA.

2.4. Application

For all appeals, the parcel owner (or an approved representative thereof) must submit an application as outlined in Section 3 to the City of Meadville regarding the nature of the appeal. Applications and documentation requirements are detailed in the following sections.





3. Application Procedures and Review Process

3.1. Application Forms

Application forms are provided in Appendix A and are available on-line at:

www.cityofmeadville.org/stormwater

3.2. Application Deadline

All appeal applications must be received by the City by September 30th in order to for any approved adjustments to be reflective on the next bill (which is issued in January each year).

3.3. Application Fee

There is no fee for an appeal with regard to errors or inaccuracies within the billing system.

The application fee for a Stormwater Special Conditions Appeal is \$25; this fee is non-refundable. Application fees may be paid by check or money order to *The City of Meadville – Stormwater Program*.

3.4. Documentation Requirements

At the time of appeal, the property owner(s) will need to provide the following documentation:

- Completed and Signed Application Form; and
- Written statement regarding the nature of the appeal.

For appeals related to the amount of imperviousness/ERU value, the applicant must provide the following:

- A plot plan, map, aerial image or similar information detailing actual impervious surfaces currently on-site.
- A requested value, in the applicant's opinion, for the correct impervious area/ERU value associated with the property for which an appeal is being requested.

For SCAs, the applicant must provide the following:

- Application Fee (non-refundable) of \$25;
- A plot plan, map, aerial image or similar information delineating the drainage areas or patterns on-site.

The Stormwater Program Staff may request additional documentation including but not limited to additional survey information in order to aid in review of the SCA.

3.5. Application Submission

The completed application, supporting documentation, and any applicable non-refundable application fee must be submitted to:

3.6. Appeal Determinations

The Stormwater Program Staff will review the required documentation and a written approval or denial of the appeal application will be issued by the City Manager.

3.7. Appeal of Determinations

In accordance with the adopted ordinance, any person aggrieved by any decision of the City Manager, may appeal to the Crawford County Court of Common Pleas within thirty (30) days of receipt of such written decision.

3.8. Billing Error Corrections

Following approval of a billing error appeal, the Stormwater Program Staff will correct the associated billing information.

3.9. Special Conditions Reduction of Stormwater Fee

If a property owner's SCA is approved, the maximum amount the property's stormwater fee may be reduced is 50%. The reduction in fee will only be applied to the portion of the impervious area that the property owner has demonstrated has less impact on the system or program of services and drains outside of the City.

SCA Fee Reduction= (Impervious Area Impacted) * (Stormwater User Fee per ERU) * (50%)

3.10. Administration of Appeals – Initial Program Year

During the initial year of the stormwater program, the City will reimburse appeals which result in a reduction of the property's stormwater fee in the form of a rebate. As payments may be made on a quarterly basis, the rebate will be applied to any of the previous payments received within the calendar year prior to September 30th, 2013. If the property owner has paid in-full their annual stormwater fee prior to the issuance of an appeal, a rebate for the full reduction in the stormwater fee will be issued.
